9 School house lease

SC gave feedback from the meeting with Michael Mill on 2 July 2019. The school house is separate from the main building and the Diocese is happy with how the building is being used for education and being kept in a good state of repair. Going forward will consider removing the lease with options for incorporating the school house into the fabric of building. Ownership would be held on trust but the LA would take on major works. MM discussed the option of changing the school status to voluntary aided (VA) – currently voluntary controlled (VC). PB outlined the difference between VC and VA and suggested that the option be considered by governors. It was agreed to invite MM to come and speak to governors about VA status. A licence agreement will be investigated which would be a more informal arrangement than a lease. A template licence to be forwarded for consideration.

SC informed governors that Geraldine Brierley has contacted pre-school regarding an account relating to the school house containing £10,000. This amount has been given to Claire and is currently in the pre-school account. It was agreed that a Lindale governors account be set up and this money transferred. The account to be managed by governors and funds to be used for the ongoing upkeep and development of the school house. HK to investigate setting up an account. It was suggested that SC, KL and one other should be signatories.
